General Information:

<u>Date, Time and Location:</u> Saturday March 2nd, 2024 11:00 a.m. -3:00 p.m. Little Mountain Park, Little Mountain, SC.

Entry Fee and Deadline: \$225 per team (Made payable to Mid-Carolina High School), due no later than February 21st, 2024.

<u>Teams:</u> Competition is limited to the first 25 cooking teams. There can be no more than four (4) persons on a team.

Cooking Instructions and Rules:

- Teams may prepare the provided Boston Butts anyway they want if it is suitable to be served to the public.
- Teams must prepare the barbeque on site at Little Mountain Park. The meat will be provided by the host site and will be available for pickup beginning at 12:00 Noon on Friday March 1st.
- Each team will be responsible for cooking a case (8 butts) of Boston Butts.
- Teams are expected to serve their barbeque to the public from 11:00am. until 2:00p.m.
 MCHS Football will provide teams with the necessary containers to serve the barbeque to the public.

- The teams will have a 30'x30' cooking area. No two-story structures are allowed. All belongings and materials must be contained in the cooking area. Water and electricity will be available. If additional space or requirements are needed, please contact Chris Arnoult at (803) 414-4435.
- The teams will NOT sell food or beverages to the public. Under NO circumstances are alcoholic beverages to be distributed.
- All teams are asked to remain professional and respect the rights of the other cook teams (space, language, loud music) and to conduct themselves in a professional manner always.

Judging and Awards

Blind judging will begin promptly at 10:00am. on Saturday March 4, 2023. Judging will be conducted by the South Carolina Barbeque Association (SCBA). Participants can earn points toward the Master Barbeque Award competition sponsored by the SCBA. Winners will be announced, and awards presented at 2:00p.m. Awards are as follows:

First Place Trophy and \$1,500 (and free entry into next year's event)

Second Place Trophy and \$1,000

Third Place Trophy and \$500

Fourth Place Trophy

*There will also be a People's Champ that will be voted on by the attending public and the winner will receive \$250 and a trophy.

Clean-Up:

All Teams are asked to clean up their assigned cooking areas and return the site to pre-competition conditions. The area must be cleaned before 5:00pm. on Saturday March 4, 2023. The Head Cook will be the responsible party for fulfilling this requirement. No staying overnight on Saturday March 4, 2023.
