General Information

Date, Time and Location: Saturday, May 4, 2024, 11:00 A.M.–1:30 P.M., Saluda Shoals Park, Columbia, SC.

Entry Fee and Deadline: \$215 per team (*credit card or check made payable to ICRC*), due no later than **Sunday, April 7, 2024**. The fee includes an approximate 30 x 30 spot with 20 amps of electricity. Additional amps are available for a fee.

Teams: Competition is limited to the first **20 cooking teams**. There can be no more than four (4) persons on a team.

Cooking Instructions and Rules

- Teams may prepare and cook the pork in any fashion they prefer so long as it is suitable to be served to the public.
- Teams must prepare the barbecue on site at Saluda Shoals Park. The meat will be furnished and will be available for pickup **beginning at approximately 1:00 P.M. on Friday, May 3, 2024**.
- Each team will be responsible for cooking a minimum of 8 butts averaging approximately 8 pounds each.
- Each team must supply their own ingredients, grill, tools, and all materials needed by the team.
- Teams are expected to serve their barbecue to the public from 11:00 A.M. until 1:30 P.M. ICRC will provide each team with the containers necessary to serve the barbecue to the public.
- Each team will have a total cooking area of approximately 30 X 30. No two-story structures are allowed, and no on-site expansion beyond the allotted area will be allowed. All belongings must be entirely contained within the allotted area. Water and 20 amps of electricity will be provided, if you need more than 20 amps, *it must be requested in advance and there will be an additional fee*.
- The teams may NOT sell food or beverages to the public. Under NO circumstances are alcoholic beverages to be distributed to the public by the teams.
- All teams are requested to respect the rights of others with special emphasis against loud music, profane language and infringement on adjoining sites.
- **Teams must have gloves, chop the pork under cover, and have a hand washing station.**
- **No overnight camping prior to May 3, 2024 or after the contest on May 4, 2024.**

Judging and Awards

Blind judging will begin promptly at 10:00 A.M. on Saturday, May 4, 2024. Judging will be conducted by the **South Carolina Barbecue Association (SCBA)**. Participants have the opportunity to earn points toward the **Master Barbecue Award** competition sponsored by the SCBA. Winners will be announced and awards presented at 1:45 P.M. Awards are as follows:

First Place	Trophy and \$1,200
Second Place	Trophy and \$600
Third Place	Trophy and \$300

Clean-Up

All teams are asked to clean up their assigned cooking areas and return the site to pre-competition conditions. **The area must be cleaned before 6:00 P.M. on Saturday, May 4, 2024.** The head cook will be the responsible party for fulfilling this requirement.
