All proceeds will benefit the children and families of Tamassee DAR School.

#### **COMPETITION DETAILS:**

- 1. Friday, June 7, 2024: Meat will be available at 1:00 PM; Cooks meeting at 3:00 PM.
- 2. Saturday, June 8, 2024: Boston butts must be turned in at 10:00 AM to be judged by SCBA. Awards will be presented at or before 2:00PM. Sales to general public begins at 11AM.
- 3. Cash prizes are as follows for Boston Butts: First Place: \$1000; 2nd Place: \$500; and Third Place: \$250.
- 4. Boston Butts will be provided. Teams will receive six (6) Boston Butts. Each team will receive sample tasting cups, forks and napkins for sale to the general public.
- 5. Cooking sites are up to 25' x 35'. All belongings must be entirely contained within the 25' x 35' area. Please respect the School's property and be careful not to damage any landscaping or other property. No pets are allowed. Minimal electricity and water will be provided for cooking and wash down purposes, but please bring normal electrical cords needed and DHEC approved water hoses. Generators are suggested for personal power needs. There will be limited capacity for self-contained campers. Please inquire for details, if applicable.
- 6. This is a rain or shine event.

### **COMPETITION RULES:**

- 1. Setup time: Begins Friday, June 7, 2024 at 10:00AM; All teams must be in place by 3:00PM.
- 2. SCDHEC: All SCDHEC rules and guidelines apply. Teams sites must be clean and ready for inspection by 4:30PM on Friday, June 7, 2024. After cooking, all meat must be maintained at a minimum of 150 degrees.
- 3. Teams may not sell or distribute any form of beverages to the public, including alcoholic beverages. Team members should respect the rights of others with special regard to music volume, profane language, and infringement on adjoining sites. Team members must conduct themselves in a professional manner or may be asked to leave.
- 4. Cooking sites must provide hand washing station, soap and paper towels, bucket for disposal water, and a probe thermometer. Food prep shall be done under a tent. No open fires/dug pits allowed.
- 5. Tent/Fire Rules: Teams are required to possess a 10BC fire extinguisher and to comply with the rules of the local Fire Marshall. All tents must have a 50lb weight attached to each leg. All tents that cover or are close to cooking grills must be NFPA 701 Flame Retardant type tents.
- 6. Clean-up: Cookers are encouraged to leave their cooking site intact until the awards presentation. No cookers are allowed to be left on the premises. It is the team's responsibility to clean their cooking sites upon completion of the event.
- 7. Rules of the South Carolina Barbeque Association shall be followed. A copy of the rules is available on our website at www.tdarschool.org or upon request.
